forward, we would like one person to focus on math so that students can also make progress in this area.

Recommendation 2:

Community Rep- The Community Rep, in conjunction with the PSA and PSW, will provide parents and students with resources to succeed in school and in LA, CA.

Reason: There has been an influx of new, newcomers and so resources to help parents and students adjust both academically and socially will allow students to succeed.

These recommendations were written on Attachment K to send to SSC.

The advisory committee moved a motion to send a written recommendation to the SSC regarding programs and services to support students' academic needs. The motion was made by Erica Amador, member, and seconded by Victoria Alonzo, member. The results were 4 in favor, 0 opposed, and labstentions. The motion carried.
